

## **KORG USA Spector Bass Giveaway Official Rules**

**NO PURCHASE NECESSARY.** The **KORG USA Spector Bass Giveaway** (“Promotion”) takes place beginning at 9:00am EST, October 1, 2015 and ends at 11:59 PM EST, October 30, 2015 (the “Promotion Period”). The Promotion is sponsored by Korg USA, Inc., 316 South Service Road, Melville, NY 11747 (“Sponsor”). All federal, state and local laws apply. Void where prohibited.

**Eligibility:** The Promotion is open to all residents of the 50 United States and Washington D.C. who are at least 18 years old, have reached the age of majority in their state of residence, and who have internet access at the time of the Promotion Period. **Selection:** Winners will be randomly selected from all eligible entries on the last business day of each week. Odds of winning will depend upon the number of eligible entries received each week of the Monthly Drawing during the Promotion Period.

**Prizes:** There will be one (1) prize awarded each month during the Promotion Period, consisting of one PER4MR bass, **valued at \$399.** All prizes will be awarded as described. No substitution or transfer of prizes, except at the sole discretion of the Sponsor, if the advertised prize becomes unavailable.

The Potential Winners are required to contact the Sponsor within 5 business days of that month’s drawing.
